Completion of the MLT(ASCP) Certification and the program should meet the educational requirements in these states and will meet requirements for states that do not require licensure. The state of Georgia does not license laboratory personnel but does specify personnel requirements that are more stringent than those required by the Clinical Laboratory Improvement Amendments of 1988 (CLIA). Certification is utilized by every state that licenses laboratory personnel to assess the initial competency of licensure candidates.
