CALL TO ORDER JUNE 13, 2022:

Chair Oda called the special meeting of the Board of Trustees to order at 2:00 PM.

ROLL CALL:

INTRODUCTIONS:

Chair Oda introduced Kara Myers, Director of Human Resources and Heather Lanham, Sr. Executive Assistant to the President and Secretary to the Board of Trustees

**EXECUTIVE SESSION:** 

Chair Oda asked for a motion for the board to go into executive session for the purpose of discussing personnel matters, specifically, the employment of a public employee.

Trustee Mehaffie <u>moved</u>, seconded by Trustee Milligan, for an executive session in compliance with the Ohio Revised Code.

On roll call vote with Trustees Mehaffie, Milligan, Baird Ganley, Baker-Baumann, Dubbs, Fortkamp, Gutmann, Heitmeyer and Oda voting aye, the chairman declared <u>the</u> motion carried.

Chair Oda adjourned for an executive session at 2:03 PM for the purpose stated.

PUBLIC SESSION:

Chairman Oda resumed public session of the Board of Trustees at 5:11 PM.

NEGOTIATION OF CONTRACT WITH CANDIDATE:

Chair Oda <u>moved</u>, seconded by Trustee Dubbs, that the Executive Committee of the Board of Trustees be empowered to negotiate the presidential contract as necessary to secure the candidate.

On roll call vote with Trustees Oda, Dubbs, Baird Ganley, Baker-Baumann, Fortkamp, Gutmann, Heitmeyer, Mehaffie and Milligan voting aye, the chairman <u>declared the</u> motion carried.

RESOLUTION FOR HIRE:

Chair Oda <u>moved</u>, seconded by Trustee Fortkamp, that the Executive Committee of the Presidential Search Committee of the Board of Trustees be empowered to draft a resolution for the hire of candidate Christopher D. Spradlin, for consideration of approval at the June 22, 2022 Board meeting, with the following provisions: Mr. Spradlin will hold the title of "President Designee" from July 1, 2022 through December 31, 2022. The title of "President" will commence January 1, 2023.

On roll call vote with Trustees Oda, Fortkamp, Baird Ganley, Baker-Baumann, Dubbs, Gutmann, Heitmeyer, Mehaffie and Milligan voting aye, the chairman <u>declared the</u> motion carried.

## FINAL DECISION PRESENTED TO CANDIDATE SPRADLIN:

Mr. Spradlin was asked to return to the board room wherein the Board of Trustees offered him the position of the next President of Edison State Community College upon the retirement of current President Dr. Doreen Larson. Chair Oda stated that the decision was made unanimously.

Mr. Spradlin was given a few days to reply to the offer and was asked to send his decision to Chair Oda and Director of HR, Kara Myers. Upon his acceptance, Chair Oda, along with Vice Chair Baker-Baumann and Kara Myers, will commence with contract negotiations in order to determine the conditions of employment.

Mr. Spradlin thanked the Trustees for the offer and happily accepted, stating that he will send an official written acceptance. The Trustees thanked Mr. Spradlin for participating in such a lengthy interview process and congratulated him on becoming the sixth President of Edison State Community College.

With no further business to come before the board Vice Chairman Milligan declared <u>the</u> meeting adjourned at 5:31 PM.
