- The College is currently preparing for an HLC accreditation visit on February 26-27, 2024.
- Accreditation confirms an institution's eligibility to receive federal student financial aid as well as overall institutional quality and academic program quality.
- The College must prove five criteria for accreditation:
 - 1. Mission
 - 2. Integrity: Ethical and Responsible Conduct
 - 3. Teaching and Learning: Quality, Resources, and Support
 - 4. Teaching and Learning: Evaluation and Improvement
 - 5. Institutional Effectiveness, Resources, and Planning
- HLC reviewers will visit campus in February in order to conduct interviews with Edison State faculty, staff, students, administration, and members of the Board of Trustees

TRUSTEE OPEN FORUM:

50th Anniversary Updates

- Trustee Oda reported that the Disc Golf Tournament will take place on September 30th.
- Trustee Oda also informed the Board that the 50th anniversary events will culminate with an Anniversary Gala on May 11th, which is the day after commencement.
