Course Description

An in-depth study of accounting theory and application of problem solving. Emphasis is on financial statement preparation; in-depth study of cash, temporary investments, receivables, inventories and non-current operating assets. Prerequisite: ACC 121S or department permission.

Assignment Details

- **Problems & Quizzes**

Problems: 3 attempts via MyAccountingLab

Quizzes: 2 attempts per chapter; theory-focused

- **Discussion Boards**

Thoughtful post + 3 replies per assignment required

Promotes peer engagement across formats

- **Crocs Project**

A multi-part project using the CROCS 2024 Annual Report to build real-world financial analysis skills. Students complete a sequence of short assignments, including a:

- business overview quiz
- financial statement quiz
- ratio calculations (Excel workbook)
- reflection connecting learning to professional readiness

All components are submitted through Blackboard.

- **Ethical Case Analysis**

Explores ethical decision-making in accounting contexts

Encourages critical thinking and communication

- **Time Value of Money Problems**

Applied calculator-based TVM practice using the HP10Bii+ (or approved emulator/app).

- **Cozy Nest Capstone Project**

A three-part real-world style project completed across the final module:

- **Part 1: Financial Calculations Test**
- **Part 2: Excel Upload + Short Analysis**
- **Part 3: Executive Summary to the Owner**

Integrates Excel, financial analysis, and professional communication.

- **Career Readiness Projects**

- Includes:
- Resume
- Elevator pitch
- Virtual interview
- Job Fair attendance (mandatory)
- Reflection

Note: Non-attendance at the Job Fair results in one full letter-grade deduction plus loss of reflection credit.
